CoMoHelps is a joint effort of Heart of Missouri United Way, City of Columbia, Boone County and Community Foundation of Central Missouri. We are working with local nonprofits, community partners and government agencies to quickly determine and meet the needs of our region. Organizations adapting to public health recommendations for mitigating the spread of COVID-19 and/or serving emergent community needs stemming from the COVID-19 pandemic are encouraged to apply for COVID-19 funds with the following stipulations in mind:

- Organizations must be able to demonstrate (1) a tracked increase in service needs or (2) a reduction in funding or (3) a need for funds to adapt service delivery and/or administrative procedures as a result of the pandemic. Organizations may compare service needs year-over-year or any time frame that demonstrates the need in relation to the pandemic.
